TEMPORARY TRAFFIC REGULATION ORDERS 2024 (NORWICH)
Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

HEIGHAM ROAD AND MILL HILL ROAD - 1) Heigham Road from its junction with Earlham Road for 15m northwards; and **2) Mill Hill Road** from its junction with Earlham Road for 15m southwards; to facilitate emergency subsidence repair works on Earlham Road by Anglian Water from 28th May to 21st June 2024. Alternative route is via: 1) Earlham Road, Unthank Road, Convent Road, Grapes Hill, Dereham Road, Heigham Road and vice versa; and 2) Earlham Road, Park Lane, Mill Hill Road and vice versa.

LOWER CLARENCE ROAD from its junction with Thorpe Road to its junction with Clarence Road to facilitate footway reconstruction works. The road will be temporarily closed (except for access) and traffic using the road will be temporarily prohibited from parking, stopping and loading/unloading from 27th May to 9th August 2024. Alternative route is via: Eastbound – Thorpe Road, Carrow Road and Clarence Road. Westbound - Clarence Road and Thorpe Road.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

FARROW ROAD - (northbound carriageway only) from its junction with Earlham Road to its junction with Bowthorpe Road to facilitate surface dressing and lining works between 19:00 and 06:00 from 18th to 30th May 2024 for the duration of the works only while signs indicating the closure are in place expected to be 2 separate nights within the period. Alternative route is via: Earlham Road, Unthank Road, Convent Road, Grapes Hill, Dereham Road, Guardian Road.

NEWMARKET ROAD – from its junction with Camberley Road to its junction with Daniels Road Roundabout to facilitate resurfacing, stud and lining works by Norfolk County Council from 20th May to 8th June 2024. Alternative route is via: Southbound route; Daniels Road, Ipswich Road, A47, A11 Newmarket Road. Northbound route; Daniels Road, Ipswich Road, A47, A11, Newmarket Road (Norwich, Cringleford, Keswick and Intwood, Caistor St. Edmund and Bixley, Ketteringham).

WESTWICK STREET CYCLE LANE - from 45m west of its junction with Charing Cross for 10m westwards to facilitate gas works from 20th to 22nd May 2024. Alternative route – St Benedicts Street.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
