**TEMPORARY TRAFFIC REGULATION ORDERS 2024 (NORWICH)**  
**Road Traffic Regulation Act, 1984**

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

**(i) THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

**ADELAIDE STREET CYCLE LANE** - from its junction with Belvoir Street to 15m west of its junction with Alexandra Road to facilitate gas works from 24th June to 12th July 2024 (may continue until the 23rd August 2024). Alternative route is via: N/A.

**ONLEY STREET** - from its junction with Unthank Road to its junction with Leicester Street to facilitate water main replacement works. The road will be temporarily closed and traffic over the Road shall be temporarily prohibited to park, stop, load, and/or unload from 24th June to 2nd August 2024 (may continue until 2nd February 2025). Alternative route is via: Unthank Road, Gloucester Street, Leicester Street.

**ST BENEDICTS STREET** - from its junction with Grapes Hill to its junction with St. Swithins Road to facilitate footway reconstruction works by Norfolk County Council from 24th to 28th June 2024 only whilst signs indicating closure are in place (may continue until the 9th August 2024). Alternative route is via: Barn Road, Westwick Street, St Swithins Road, St Margarets Street, St Benedicts Street.

**TOMBLAND AND UPPER KING STREET – 1) Tombland/ Upper King Street** from its junction with Palace Street to its junction with Prince of Wales Road will be temporarily closed; and traffic over the **2) Prince of Wales Road** from its junction with Upper King Street to its junction with Eastborne Road will be temporarily prohibited to park, stop, load, and/or unload to facilitate carriageway rejuvenation works between 06:00 and 11:00 on the 23rd June 2024 (may continue until 4th August 2024). Alternative route is via: Southbound route – Palace Street, St Martin at Palace Plain, Whitefriars, Barrack Street, Bishop Bridge Road, Riverside Road, Rose Lane, Prince Of Wales Road, Market Avenue and Agricultural Hall Plain. Northbound route - Prince of Wales Road, Riverside Road, Bishop Bridge Road, Barrack Street, Whitefriars, St Martin at Palace Plain and Palace Street.

**WOODHILL RISE AND LEEWOOD CRESCENT – 1) Woodhill Rise** from 80m south of its junction with Oval Avenue to 15m north of its junction with Leewood Crescent will be temporarily closed and traffic over the **2) Leewood Crescent** for its entirety shall be prohibited to park, stop, load, and/or unload to facilitate footway resurfacing works by Norfolk County Council from 24th June to 23rd August 2024 (may continue until the 23rd February 2025). Alternative route is via: Oval Avenue, Oval Road and Olive Road (Norwich and Costessey).

**(ii) THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following roads:

**BORROWDALE DRIVE** - from its junction with Heartsease Lane for 20m westwards to facilitate telecoms mast installation works between 08:00 on 17<sup>th</sup> June and 18:00 on 19<sup>th</sup> June 2024 (may continue until 31<sup>st</sup> July 2024). Alternative route is via: Heartsease Lane, Plumstead Road, Hilary Avenue, Borrowdale Drive and vice versa.

**HELLESDON MILL LANE** - from 55m west of its junction with Hellesdon Road for 50m westwards to facilitate telecoms pole testing between 09:30 and 15:30 on the 21<sup>st</sup> June 2024 (may continue until 2<sup>nd</sup> August 2024). Alternative route is via: Hellesdon Road, Hellesdon Mill Lane.

**THE RIDGEWAY** - from its junction with Gerald Close to its junction with Steepgreen Close to facilitate repairs of a damaged water main from 17th to 25th June 2024 (may continue until 6th August 2024). Alternative route is via: The Ridgeway, Borrowdale Drive.

**ROSE LANE - Rose Lane** from its junction with Mountergate to its junction with Cattle Market Street ("Road A"); and **Cattle Market Street (southbound only)** from its junction with Rose Lane to its junction with Rouen Road ("Road B"); and **Market Avenue** from its junction with Cattle Market Street to its junction with Agricultural Hall Plain ("Road C"); and **St Vedast Street** from its junction with Prince of Wales Road to its junction with Rose Lane ("Road D"); to facilitate carriageway treatment works. Vehicles using the Roads A - D will be temporarily closed (except for pedestrian access) and Road C shall be temporarily subject to the suspension of the bus lane between 06:00 and 19:00 on the 16<sup>th</sup> June 2024 (may continue until 28<sup>th</sup> July 2024). Alternative route will be as signed on site.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s)/ footpath(s). In the event of the start date being delayed the new start date will be displayed on site in advance. Where an Order is for a reason other than works it is because of the likelihood of danger to the public or of serious damage to the road/footpath. **Anticipated dates are stated but the Orders may continue until the end date where necessary or required.** The Orders are revoked on the end date or on the actual date of removal of the prohibition/restriction where earlier without further notice. If necessary, the restrictions can have a maximum duration of 18 months for vehicular highway or 6 months for non-vehicular highway.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
