Norfolk County Council (Norwich, Muspole Street) Emergency Notice Temporary Traffic Regulation Order 2024 Section 14(2) of the Road Traffic Regulation Act 1984

Norwich, Muspole Street (CTRO1016) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to repairs of a burst water main the use by vehicles (of any class/specific class) of the Muspole Street from 70m west of its junction with Duke Street for 50m southwards (the "Road A") and Muspole Street from its junction with Duke Street to its junction with Colegate (the "Road B")shall be temporarily subject to the suspension of the one-way system (southbound) to allow vehicles to travel in both a north and south direction in the City of Norwich will be temporarily prohibited/restricted.

Alternative route is via: Duke Street, Saint Crispins Road, Whitefriars, Palace Street, Wensum Street, Fye Bridge Street, Colegate

The closure/restriction is necessary because of the likelihood or danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 25th to 29th July 2024 but the Road A and the Road B may continue to be closed/restricted until the 14th August 2024 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 14th August 2024 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
