## Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2024 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

**BLUEBELL ROAD -** from 20m northwest of its junction with Norvic Drive for 20m south-eastwards to facilitate Norfolk County Council defected reinstatement repairs works from 28th to 30th October 2024 (may continue until 11th December 2024). Alternative route is via: Southbound Diversion - South Park Avenue Colman Road, Newmarket Road, Eaton Street Bluebell Road; Northbound Diversion - Newmarket Road, Colman Road, South Park Avenue.

**CECIL ROAD** - from its junction with Trafford Road for 40m westwards to facilitate Cadent gas connection works from 28th October to 1st November 2024 (may continue until 13th December 2024). Alternative route is via: Cecil Road, Hall Road, Lakenham Road, Ipswich Road.

**COLLEGE ROAD** - from its junction with Earlham Road for 50m southwards to facilitate Cadent gas works from 28th October to 8th November 2024 (may continue until 20th December 2024). Alternative route is via: Earlham Road, Recreation Road, The Avenues, College Road.

**ST. SWITHIN'S ROAD (Cycle Lane) -** from its junction with St. Within's Alley for 100m south westwards to facilitate works for a new water connection on the 28th October 2024 (may continue until 9th December 2024). Alternative route is via: N/A.

**SURREY STREET -** from its junction with Surrey Grove to its junction with Chapel Loke to facilitate elevated access to Norfolk Tower. The road will be temporarily closed, and traffic will be temporarily prohibited to park, stop, load, and/or unload between 10:00 and 17:00 on 27th October 2024 (may continue until 8th December 2024). Alternative route is via: Surrey Street, All Saints Green, Queens Road, St Stephens Roundabout, Queens Road, Surrey Street and vice versa.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

BER STREET - 1) City Road onto Bracondale; 2) Queens Road onto City Road; 3) Ber Street onto Queens Road; and 4) Bracondale onto Ber Street to facilitate sluice valve repairs. The Roads 1), 2) 3) and 4) will be temporarily subject to a no right turn restriction from 21st to 23rd October 2024 (may continue until the 4th December 2024). Alternative route is via: 1) City Road, Queens Road, Finkelgate, Ber Street, Bracondale; 2) Bracondale, Martineau Lane, Barrett Road, Long John Hill, City Road; 3) Bracondale, Martineau Lane, Barrett Road, Long John Hill, City Road; and 4) City Road, Queens Road, Finkelgate, Ber Street, Bracondale.

**CASTLE MEADOW** - from its junction with Farmers Avenue for 50m northwards to facilitate Norfolk County Council carriageway works from 25th October to 1st November 2024 (may continue until the 13th December 2024). Alternative route is via: Northbound: Farmers Avenue, Cattle Market Street, Market Avenue Southbound Route Castle Meadow, Agricultural Hall Plane, Prince of Wales Rd, Saint Vedast Street, Rose Lane, Cattle Market Street and Farmers Avenue.

CHRISTCHURCH & LIME TREE ROAD – 1) Christchurch Road from its junction with Newmarket Road for 60m westwards and 2) Lime Tree Road from its junction with Newmarket Road to its junction

with Fairfield Road to facilitate Norfolk County Council drainage and lining works from 21st to 25th October 2024 (may continue until the 6th December 2024). Alternative route is via: 1) Newmarket Road, Mile End Road, Unthank Road and vice versa and; 2) Newmarket Road Daniels Road and Ipswich Road.

**DIAMOND ROAD** - from 50m west of its junction with Vulcan Road North for 20m westwards to facilitate safe access and egress from site. Traffic over the road shall be temporarily prohibited to park, stop, load, and/or unload from 21st October 2024 to 15th April 2025 (may continue until 14th April 2026), (previously 16th to 20th October 2024). Alternative route is via: N/A.

**IPSWICH ROAD** - from its junction with Hall Road for 300m northwards to facilitate Norfolk County Council bus lane installation and traffic signal upgrade works from 21st to 30th October 2024 (may continue until the 11th December 2024). Alternative route is via: Ipswich Road, Lakenham Road, Hall Road.

**LINCOLN STREET -** from its junction with Unthank Road to its junction with Portersfield Road to facilitate Anglian Water replacement of lead water main works. The road will be temporarily closed and; traffic over the Road shall be temporarily prohibited to park, stop, load, and/or unload from 21st October to 13th December 2024 (may continue until the 13th June 2025. Alternative route is via: Unthank Road, Portland Street, Portersfield Road.

**WESTLEGATE -** from its junction with All Saints Green for 50m north-westwards to facilitate Anglian Water pipe repairs from 22nd to 24th October 2024 (may continue until the 5th December 2024). Alternative route is via: All Saints Green, Queens Road, St. Stephens Roundabout, Chapel Field Road, Grapes Hill, Chapel Field North, Theatre Street, Rampant Horse Street.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s)/ footpath(s). In the event of the start date being delayed the new start date will be displayed on site in advance. Where an Order is for a reason other than works it is because of the likelihood of danger to the public or of serious damage to the road/footpath. **Anticipated dates are stated but the Orders may continue until the end date where necessary or required.** The Orders are revoked on the end date or on the actual date of removal of the prohibition/restriction where earlier without further notice. If necessary, the restrictions can have a maximum duration of 18 months for vehicular highway or 6 months for non-vehicular highway.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
