

**Norfolk County Council**  
**TEMPORARY TRAFFIC REGULATION ORDERS 2025 (NORWICH)**  
**Road Traffic Regulation Act, 1984**

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

**(i) THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

**GLENMORE GARDENS** - from 260m west of its junction with Aylsham Road for 20m westwards to facilitate new connection works from 25th to 27th February 2025 (may continue until 10th April 2025). Alternative route is via: Glenmore Gardens.

**HENLEY ROAD AND SPELMEN ROAD - 1) Henley Road** from its junction with Spelman Road for 110m south-westwards and **2) Spelman Road** from 20m northwest of its junction with Henley Road for 40m south-eastwards to facilitate sewer repair works between 19:00 and 23:59 from 26th to 27th February 2025 (may continue until 10th April 2025). Alternative route is via: Grange Road, Christchurch Road, Highland Avenue and vice versa.

**MAGDALEN STREET – 1) Magdalen Street** from its junction with Edward Street for 10m northwards and **2) Magdalen Street** at its junction with Edward Street to facilitate Norfolk County Council manhole repair works. The road **1)** will be temporarily closed and the road **2)** will be restricted from turning left onto Edward Street between 23:00 and 06:00 from 23rd to 24th February 2025 (may continue until the 7th April 2025). Alternative route is via: Magdalen Street, Edward Street, New Botolph Street, Pitt Street, St Crispins Road, Charlton Road, Bull Close Road.

**SPAR ROAD** - from its junction with Vulcan Road South for 40m eastwards to facilitate Norfolk County Council manhole repair works between 19:00 and 06:00 from 25th to 26th February 2025 (may continue until the 9th April 2025). Alternative route is via: Spar Road, Vulcan Road North, Burton Road.

**ST LEONARDS ROAD** - from 20m north of its junction with Gas Hill for 60m north-eastwards to facilitate UK Power Network new electrical connection works from 25th to 28th February 2025 (may continue until the 7th April 2025). Alternative route is via: St Leonards Road, Rosary Road, A147 Riverside Road, A147 Bishop Bridge Road, B1140 Ketts Hill, Quebec Road.

**(ii) THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following roads:

**ANGEL ROAD – 1) Angel Road** from its junction with Waterloo Road to its junction with Eade Road and **2) Waterloo Road** from its junction with Buxton Road to its junction with Angel Road to facilitate resurfacing works from 20th to 24th February 2025 (may continue until 7th April 2025). Alternative route is via: Northbound: Waterloo Road, Magpie Road, Botolph Street, Edward Street, St Augustines Street, Aylsham Road, Woodcock Road, Angel Road. Southbound: Angel Road, Woodcock Road, Aylsham Road, and Waterloo Road.

**BARN ROAD – 1) Barn Road (southbound only)** from its junction with Westwick Street to its junction with Dereham Road and **2) Grapes Hill (southbound only)** from its junction with Dereham Road to its junction with Chapel Field Road to facilitate Norfolk County Council infrastructure works relating to TCF scheme between 19:00 and 07:00 from 19th to 23rd February 2025 (may continue until 6th April 2025). Alternative route is via: Barn Road, St Crispins Road, Barrack Street, Bishop Bridge Road, Riverside Road, Riverside, Koblenz Avenue, King Street, Bracondale, Queens Road and Chapel Field Road.

**DEREHAM ROAD – 1) Dereham Road** from its junction with Grapes Hill to its junction with Raglan Street and **2) Grapes Hill (northbound only)** from its junction with Chapelfield Roundabout to its

junction with Dereham Road to facilitate Norfolk County Council infrastructure works relating to TCF scheme between 19:00 to 07:00 from 17th to 20th February 2025 (may continue until 3rd April 2025). Alternative route is via: Grapes Hill, Chapel Field Road, St Stephens Road, Newmarket Road, Colman Road, Farrow Road, Guardian Road and Dereham Road.

**GERTRUDE ROAD** - from 55m east of its junction with Violet Road for 40m eastwards to facilitate manhole cover and frame repair works between 08:00 and 18:00 on the 18th February 2025 (may continue until 1st April 2025). Alternative route is via: Gertrude Road, Sprowston Road, Silver Road, Mousehold Avenue, Lavengro Road.

**KINGS STREET** - from 38m south of its junction with Music Lane for 20m southwards to facilitate Anglian Water disconnection works from 18th to 24th February 2025 (may continue until the 7th April 2025). Alternative route is via: King Street, Rouen Road, Music House Lane.

**NEWMARKET ROAD** - from 120m northeast of its junction with Town Close Road for 50m north-eastwards to facilitate Anglian Water carriageway works. The road will be temporarily subject to the suspension of the existing bus lane e from 18th to 19th February 2025 (may continue until the 2nd April 2025). Alternative route is via: N/A.

**PECKOVER ROAD** - from 1m west of its junction with Pettus Road for 41m westwards to facilitate Anglian Water works on mains fitting from 18th to 20th February 2025 (may continue until the 3rd April 2025). Alternative route is via: Peckover Road, Pettus Road, South Park Avenue, Bluebell Road, Osborne Road.

**RAWLEY ROAD** - from its junction with Clover Hill Road to its junction with Holworthy Road to facilitate Cadent Gas main replacement works from 17th to 28th February 2025 (may continue until the 11th April 2025). Alternative route is via: Clover Hill Road, Rawley Road.

**ST. STEPHENS STREET** - at its junction with Surrey Street to facilitate assistance with the bus network due to works at Castle Meadow. The road shall be temporarily subject to the suspension of a no right turn restriction allowing traffic (constituting any class of vehicle) to turn right onto Surrey Street from 14th to 21st February 2025 (may continue until the 4th April 2025). Alternative route is via: N/A.

**TIMBER HILL & ORFORD Hill – 1) Timber Hill** from its junction with Golden Ball Street to its junction with Orford Hill and **2) Orford Hill** from its junction with Timbre Hill to its junction with Red Lion Street to facilitate Norfolk County Council footway reconstruction works. The roads **1)** and **2)** will be temporarily closed and shall be temporarily subject to the suspension of the one-way system (west bound) to allow vehicles to travel in both a westerly and easterly direction from 17th February to 18th April 2025 (may continue until the 18th October 2025). Alternative route is via: From; 17th to 21st February 2025: Golden Ball Street, Farmers Avenue and Red Lion Street. Thereafter from; 22nd February to 18th April 2025: Cattle Market Street, Market Avenue, Castle Meadow, Red Lion Street until completion of the works.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s)/ footpath(s). In the event of the start date being delayed the new start date will be displayed on site in advance. Where an Order is for a reason other than works it is because of the likelihood of danger to the public or of serious damage to the road/footpath. **Anticipated dates are stated but the Orders may continue until the end date where necessary or required.** The Orders are revoked on the end date or on the actual date of removal of the prohibition/restriction where earlier without further notice. If necessary, the restrictions can have a maximum duration of 18 months for vehicular highway or 6 months for non-vehicular highway.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
