

**Norfolk County Council (Norwich, Waterloo Road & Angel Road)**  
**Urgent Notice**  
**Temporary Traffic Regulation Order 2025**  
**Section 14(2) of the Road Traffic Regulation Act 1984**

Norwich, Waterloo Road and Angel Road (CTRO1206) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to urgent resurfacing works the use by vehicles (of any class) of the A) Waterloo Road from its junction with Buxton Road to its junction with Angel Road (the "Road A") and B) Angel Road from its junction with Waterloo Road to its junction with Eade Rode (the "Road B") in the City of Norwich will be temporarily prohibited

The closure/restriction is necessary or expedient because works are being or are proposed to be executed on or near the Roads.

The closure/restriction is anticipated to take place from 19<sup>th</sup> to 23<sup>rd</sup> March 2025.

This Notice shall be in effect from 19<sup>th</sup> to 23<sup>rd</sup> March 2025 or until the closure/restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the closure/restriction is no longer necessary or otherwise on the 23<sup>rd</sup> March 2025 without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

Alternative route is via: Northbound - Waterloo Road, Magpie Road, Botolph Street, Edward Street, St Augustines Street, Aylsham Road, Woodcock Road, Angel Road.  
Southbound - Angel Road, Woodcock Road, Aylsham Road, and Waterloo Road.

The works promoter for this restriction/closure is: Norfolk County Council

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.


