**Multiple Events during 2025**  
**in the City of Norwich**

**Temporary Restrictions of Traffic Movement**

Norfolk County Council has made, with the approval of the Secretary of State for Transport, a Temporary Traffic Regulation Order on 15<sup>th</sup> April 2025 to come into operation on 8<sup>th</sup> May 2025 affecting the City of Norwich to facilitate the staging of various events.

**The Events:**

**1) VE Day Service**

**1.1** The restrictions at 1.1(a) shall have effect between 09:30 and 12:30 on Thursday 8<sup>th</sup> May 2025

(a) Traffic over the following road shall be prohibited only whilst the closures are indicated on site:

St Peter's Street for its entire length.

**2) Norfolk and Norwich Festival**

**2.1** The restrictions at 2.1(a) shall have effect between 10:30 on Thursday 8<sup>th</sup> May 2025 to 05:30 on Monday 12<sup>th</sup> May 2025

(a) Traffic over the following road shall be prohibited and temporarily prohibited to park, stop, load, and/or unload only whilst the restrictions are indicated on site:

St Peter's Street Motorbike Park for its entire length.

**2.2** The restrictions at 2.2(a) and 2.2(b) shall have effect between 17:15 to 21:00 on Friday 9<sup>th</sup> May 2025

(a) Traffic over the following roads shall be prohibited only whilst the restrictions are indicated on site:

St Peter's Street for its entire length, Bethel Street from its junction with St Peters Street to its junction with The Forum Car Park entrance

(b) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload (including in existing parking bays) only whilst the restrictions are indicated on site:

St Peters Street for its entire length, Bethel Street for its entire length.

**3) Norwich 100 Cycle Ride**

**3.1** The restrictions at 3.1(a) shall have effect between 05:00 to 11:00 on Sunday 1<sup>st</sup> June 2025

(a) Traffic and pedestrians over the following roads shall be prohibited only whilst the restrictions are indicated on site:

St Peter's Street for its entire length, Millenium Plain for its entire length, Bethel Street from its junction with St Peters Street to its junction with The Forum Car Park entrance, Hay Hill for its entire length.

#### **4) D-Day Service**

**4.1** The restrictions at 4.1(a) shall have effect between 09:30 and 12:30 on Friday 6<sup>th</sup> June 2025

(a) Traffic over the following road shall be prohibited only whilst the closures are indicated on site:

St Peter's Street for its entire length.

#### **5) City Service**

**5.1** The restrictions at 5.1(a) shall have effect between 14:00 and 16:00 on Sunday 15<sup>th</sup> June 2025

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

St Peters Street for its entire length, Gaol Hill for its entire length, London Street for its entire length, Bank Plain for its entire length, Queens Street for its entire length, Tombland for its entire length.

#### **6) Armed Forces Day**

**6.1** The restrictions at 6.1(a) shall have effect between 09:00 and 12:00 on Monday 23<sup>rd</sup> June 2025

(a) Traffic over the following road shall be prohibited only whilst the closures are indicated on site:

St Peter's Street for its entire length.

#### **7) Lord Mayor's Celebrations**

**7.1** The restrictions at 7.1(a) shall have effect between 22:30 on Friday 11<sup>th</sup> July 2025 to 03:00 on Sunday 13<sup>th</sup> July 2025

(a) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Brigg Street for its entire length, Gentlemans Walk for its entire length, St Peters Street for its entire length, Chapel Field North for its entire length, Chapel Field East for its entire length, Theatre Street for its entire length, Exchange Street for its entire length, Gaol Hill for its entire length, Guildhall Hill for its entire length.

**7.2** The restrictions at 7.2(a) shall have effect between 16:00 and 22:00 on Friday 11<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Brigg Street from outside Burger King to its junction with Haymarket, Hay Market for its entire length, Gentlemans Walk for its entire length, Hay Hill for its entire length and Millenium Plain for its entire length.

**7.3** The restrictions at 7.3(a) shall have effect between 08:00 and 23:59 on Saturday 12<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Theatre Street for its entire length, Rampant Horse Street for its entire length, Gentlemens Walk for its entire length, Orford Place for its entire length, Brigg Street for its entire length, Hay Hill for its entire length, William Booth Street for its entire length, Haymarket for its entire length, Hay Hill for its entire length, Millenium Plain for its entire length, London Street for its entire length, Castle Street for its entire length, Little London Street for its entire length, Bedford Street for its entire length, Lobster Lane for its entire length, Pottergate from its junction with Upper Goat Lane to its junction with Dove Street, Dove Street for its entire length, St John for its entire length, Maddermarket for its entire length, Lower Goat Lane for its entire length, Swan Lane for its entire length, White Lion Street for its entire length, Davey Place for its entire length, Old Post Office Court for its entire length, Arcade Street for its entire length.

**7.4** The restrictions at 7.4(a) shall have effect between 12:00 and 19:00 on Saturday 12<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Exchange Street for its entire length, Gaol Hill for its entire length, Guildhall Hill for its entire length.

**7.5** The restrictions at 7.5(a) shall have effect between 13:30 and 18:00 on Saturday 12<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Tombland for its entire length, Princes Street for its entire length, Queens Street for its entire length, Upper King Street for its entire length, Bank Plain for its entire length, Bank Street for its entire length, St Andrews Street for its entire length, Redwell Street for its entire length, St Andrews Hill for its entire length.

**7.6** The restrictions at 7.6(a) shall have effect between 11:00 and 23:59 on Saturday 12<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Chapel Field North for its entire length, Chapel Field East for its entire length, Coburg Street for its entire length, Chantry Road for its entire length, Hales Court for its entire length, Ninhams Court for its entire length.

**7.7** The restrictions at 7.7(a) and 7.7(b) shall have effect between 06:00 and 19:00 on Sunday 13<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

St Gregory's Green for its entire length, St. John Maddermarket for its entire length, Pottergate from its junction with Lower Goat lane to its junction with Lobster Lane, Lower Goat Lane for its entire length, Dove Street for its entire length, Lobster Lane for its entire length, St Benedict's Street for its entire length, Bedford Street for its entire length, Little London Street for its entire length, Ten Bell Lane for its entire length, Ten Bell Court for its entire length, St Margarets Street for its entire length, Exchange Street for its entire length, Upper St Giles Street for its entire length, Millennium Plain for its entire length, Hay Hill for its entire length, Haymarket for its entire length.

(b) Traffic over the following road shall be subject to a suspension of the one-way system:

Wellington Lane for its entire length.

## **8) Pride Norwich**

**8.1** The restrictions at 8.1(a) shall have effect between 09:00 and 18:00 on Saturday 26<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Theatre Street for its entire length, Rampant Horse Street for its entire length, Gentlemans Walk for its entire length, Brigg Street for its entire length, Hay Hill for its entire length, Haymarket for its entire length, St Peter's Street Motorbike Park for its entire length.

**8.2** The restrictions at 8.2(a) shall have effect between 10:30 and 14:45 on Saturday 26<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Bethel Street from its junction with Forum Car Park Entrance to its junction with St Peters Street, St Peters Street for its entire length.

**8.3** The restrictions at 8.3(a) and 8.3(b) shall have effect between 12:45 and 14:30 on Saturday 26<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

St Giles Street for its entire length, Gaol Hill for its entire length, Guildhall Hill for its entire length, Exchange Street for its entire length, London Street for its entire length, Little London Street for its entire length, Castle Street for its entire length, Bedford Street for its entire length, Davey Place for its entire length.

(b) Traffic over the following road shall be subject to a suspension of the one-way system:

Upper Goat Lane for its entire length.

**8.4** The restrictions at 8.4(a) shall have effect between 12:45 and 16:00 on Saturday 26<sup>th</sup> July 2025

(a) Traffic over the following roads shall be prohibited and shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Chapel Field North for its entire length, Chapel Field East for its entire length, Chantry Road for its entire length, Malthouse Road for its entire length.

## **9) VJ Day Service**

**9.1** The restrictions at 9.1(a) shall have effect between 09:00 and 11:30 on Friday 15<sup>th</sup> August 2025

(a) Traffic over the following road shall be prohibited only whilst the closures are indicated on site:

St Peter's Street for its entire length.

## **10) Run Norwich 10k**

**10.1** The restrictions at 10.1(a) shall have effect between 05:00 and 13:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Bethel Street from its junction with St Peters Street to its junction with Little Bethel Street, Millenium Plain for its entire length, Rampant Horse Street for its entire length, St Peters Street for its entire length, Theatre Street for its entire length.

**10.2** The restrictions at 10.2(a) and 10.2(b) shall have effect 07:00 and 13:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Bethel Street for its entire length, Brigg Street for its entire length, Castle Meadow for its entire length, Haymarket for its entire length, Lower Goat Lane for its entire length, Red Lion Street for its entire length, Castle Street for its entire length, St Giles Street for its entire length, Davey Place for its entire length, Exchange Street from its junction with London Street to its junction with Bedford Street, Gaol Hill for its entire length, St Stephens Street from its junction with Queens Road to its junction with Red Lion Street, Upper Goat Lane for its entire length, White Lion Street for its entire length, Guildhall Hill for its entire length, Ingham Street for its entire length, Little Bethel Street for its entire length, William Booth Street for its entire length.

(b) Traffic over the following road shall be subject to a suspension of the one-way system:

St Giles Street for its entire length, Upper Goat Lane for its entire length.

**10.3** The restrictions at 10.3(a) shall have effect between 08:00 and 12:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Abbey Lane for its entire length, Agricultural Hall Plain for its entire length, Alan Road for its entire length, Bank Plain for its entire length, Bank Street for its entire length, Cattle Market Street for its entire length, Chalk Hill Road for its entire length, Crown Road for its entire length, Exchange Street for its entire length, Ferry Road for its entire

length, Greyfriars Street for its entire length, Hobrough Lane for its entire length, King Street for its entire length, Lollards Rd for its entire length, Maidstone Road for its entire length, Upper King Street for its entire length, Market Avenue for its entire length, Mountergate for its entire length, Queen Street for its entire length, Rose Lane for its entire length, Redwell Street for its entire length, Riverside (northbound only) from its junction with Station Approach to its junction with Prince of Wales Road, Riverside Road (northbound only) from its junction with Prince of Wales Rd to its junction with Bishopgate, Riverside Road (southbound only) from its junction with Rosary Rd to its junction with Thorpe Road, Sherborne Place for its entire length, St Andrews Street for its entire length, St Anne's Lane for its entire length, St John's Street for its entire length, St Matthews Road for its entire length, Stuart Road for its entire length.

**10.4** The restrictions at 10.4(a) shall have effect between 07:30 and 10:30 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Chapelfield East for its entire length, Chapelfield North for its entire length, Chapelfield Road for its entire length, Chantry Road for its entire length, Malthouse Road for its entire length, Cleveland Road (southbound only) for its entire length.

**10.5** The restrictions at 10.5(a) shall have effect between 08:30 and 10:30 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

St Stephens Street from its junction with St Stephens Roundabout to its junction with Surrey Street, Surrey Street from its junction with St Stephens Street to its junction with All Saints Green, All Saints Green from its junction with Surrey Street to its junction with Westlegate, Westlegate for its entire length.

**10.6** The restrictions at 10.6(a) shall have effect between 08:30 and 11:30 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Bedding Lane for its entire length, Quayside for its entire length, Bishopgate for its entire length, Queen Street for its entire length, Blackfriars Street for its entire length, Recorder Road for its entire length, Cathedral Close, for its entire length, St Faiths Lane for its entire length, St Martin at Palace Plain for its entire length, Cathedral Street for its entire length, Cotman Fields for its entire length, Eastbourne Place for its entire length, Elm Hill for its entire length, St Saviours Lane for its entire length, St Vedast Street for its entire length, Prince of Wales Road for its entire length, Fishergate for its entire length, Fye Bridge Street for its entire length, Goldworth's Buildings for its entire length, Magdalen Street for its entire length, Palace Street for its entire length, Pigg Lane for its entire length, Princess Street for its entire length, Stuart Gardens for its entire length, Tombland for its entire length, Upper King Street for its entire length, Wagon and Horses Lane for its entire length, Wensum Street for its entire length, Whitefriars for its entire length.

**10.7** The restrictions at 10.7(a) shall have effect between 08:30 and 11:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Canary Fields for its entire length, Wherry Road for its entire length, Carrow Road for its entire length, King Street from its junction with Bracondale to its junction with Carrow Road, Geoffrey Watling Way for its entire length, Koblenz Avenue for its entire length.

**10.8** The restrictions at 10.8(a) shall have effect between 16:00 on Saturday 6<sup>th</sup> September and 12:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Bethel Street for its entire length, Gaol Hill for its entire length, Bishopgate for its entire length, Farmers Avenue for its entire length, Prince of Wales Road for its entire length, Riverside Road for its entire length.

**10.9** The restrictions at 10.9(a) shall have effect between 09:00 on Saturday 6<sup>th</sup> September and 12:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

St Giles Street for its entire length, St Peters Street for its entire length.

**10.10** The restrictions at 10.10(a) and 10.10(b) shall have effect between 18:00 on Saturday 6<sup>th</sup> September and 12:00 on Sunday 7<sup>th</sup> September 2025.

(a) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

King Street from its junction with Rose Lane to its junction with Mountergate, Theatre Street for its entire length, Chapelfield Road East for its entire length, Farmers Avenue for its entire length, St Saviours Lane for its entire length, All Saints Green for its entire length, Brigg Street for its entire length, Gentleman's Walk for its entire length.

(b) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload on single yellow lines only whilst the restrictions are indicated on site:

Bishopgate (northside) outside the Great Hospital Gates, Upper King Street (westside) from its junction with Bank Street to the bus stand, Wensum Street (westside) for its entire length, Magdalen Street (westside) from outside Boswell's Yard to outside 28 Magdalen Street, Magdalen Street (westside) from outside Colegate to outside 8 Magdalen Street.

## **11) Battle of Britain**

**11.1** The restrictions at 11.1(a) shall have effect between 07:00 and 14:00 on Monday 15<sup>th</sup> September 2025

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Bethel Street for its entire length, Gaol Hill for its entire length, Guildhall Hill for its entire length, St Giles Street for its entire length, St Peter's Street for its entire length, Upper St Giles Street for its entire length.

**11.2** The restrictions at 11.2(a) shall have effect from 22:00 on Sunday 14<sup>th</sup> September 2025 and 14:00 on Monday 15<sup>th</sup> September 2025

(a) Traffic over the following roads shall be temporarily prohibited to park, stop, load, and/or unload (including in existing parking bays that are not Car Club bays) only whilst the restrictions are indicated on site:

St Peters Street for its entire length, Bethel Street from its junction with St. Peters Street to its junction with The Forum Car Park entrance, St Giles Street from outside the Waffle House to its junction with the St Peters Street.

Please note during these restrictions there will be a relocation of a Taxi Rank from Gaol Hill to outside the Waffle House and Futon Company on St Giles Street.

## **12) Remembrance Sunday**

**12.1** The restrictions at 12.1(a) and 12.1(b) shall have effect between 07:00 and 12:00 on the Sunday 9<sup>th</sup> November 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Bethel Street for its entire length, Gaol Hill for its entire length, Guildhall Hill for its entire length, St Giles Street for its entire length, St Peter's Street for its entire length.

(b) Traffic over the following road shall be subject to a suspension of the one-way system:

Upper Goat Lane for its entire length.

**12.2** The restrictions at 12.2(a) shall have effect between 11:00 and 12:30 on the Sunday 9<sup>th</sup> November 2025.

(a) Traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

London Street for its entire length, Opie Street for its entire length, Castle Meadow for its entire length, Agriculture Hall Plain for its entire length, Upper King Street for its entire length, Tombland for its entire length.

## **13) Armistice Day**

**13.1** The restrictions at 13.1(a) shall have effect between 09:30 and 12:30 on Tuesday 11<sup>th</sup> November 2025

(a) Traffic over the following road shall be prohibited only whilst the closures are indicated on site:

St Peter's Street for its entire length.

## **14) Norwich Xmas Lights Switch-on Event**

**14.1** The restrictions at 14.1(a) shall have effect between 08:30 and 23:00 on Tuesday 20<sup>th</sup> November 2025

(a) Traffic over the following roads shall be prohibited and temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

St Peters Street for its entire length, Millenium Plain for its entire length, Bethel Street from its junction with the Forum Car Park Entrance to its junction with St Peters Street.

**14.2** The restrictions at 14.2(a) shall have effect between 12:00 and 23:00 on Tuesday 20<sup>th</sup> November 2025



(a) Traffic over the following roads shall be prohibited and temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

Brigg Street for its entire length, Gentleman's Walk for its entire length, Hay Hill for its entire length, Haymarket for its entire length, Millenium Plain for its entire length.

**14.3** The restrictions at 14.3(a) and 14.3(b) shall have effect between 16:00 and 23:00 on Tuesday 20<sup>th</sup> November 2025

(a) Traffic over the following roads shall be prohibited and temporarily prohibited to park, stop, load, and/or unload in all existing parking bays only whilst the restrictions are indicated on site:

St Giles Street for its entire length, Gaol Hill for its entire length, Exchange Street for its entire length, Pottergate from its junction with Upper Goat Lane to its junction with Exchange Street, London Street for its entire length, Little London Street for its entire length, Castle Street for its entire length, Dove Street for its entire length, St John Maddermarket for its entire length.

(b) Traffic over the following road shall be subject to a suspension of the one-way system:

Upper Goat Lane for its entire length.

Please note during these restrictions there will be a relocation of a Taxi Rank from Gaol Hill to outside the Waffle House and Futon Company on St Giles Street.

Restrictions on traffic will be enforced until normal traffic flow can be maintained following the Events. Where appropriate during the period of the closure, temporary suspension of existing permanent Traffic Orders may be imposed.

Alternative routes will be available for use while the Order is in force and shall be signed accordingly onsite. Details and a copy of the plan can be found at <https://one.network>.
