## What you must do to comply with the law

The report may include **Contraventions** - matters which do not comply with the law. You must address all of the contraventions identified; failure to do so could result in legal action being taken against you.

As a guide, contraventions relating to cleaning, temperature control and poor practice, should be dealt with <u>straight away</u>.

Contraventions relating to structural repairs, your food safety management system and staff training, should be completed within the next <u>2 months</u>.

Health and safety contraventions should be dealt with within 3 months unless otherwise stated.

To assist you the report may also include **Observations** of current practice, useful **Information**, **Recommendations** of good practice and reminders of **Legal Requirements**.

My inspection was not intended to identify every contravention of the law and only covers those areas, practices and procedures examined at the time of the inspection. If the report fails to mention a particular matter this does not mean you have necessarily complied with the law.

## How we calculate your Food Hygiene Rating:

The food safety section has been divided into the three areas which you are scored against for the hygiene rating: 1. food hygiene and safety procedures, 2. structural requirements and 3. confidence in management/control procedures. ## 1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. (Score 5)

# Contamination risks

**Contravention** The following exposed food to the general risk of cross-contamination with bacteria or allergens or its physical contamination with dirt, foreign objects or chemicals:

- personal items (such as mobile phones) close to food in food areas
- chives were not washed before being put into ready to eat coleslaw. The packet said they should be washed before use.
- despite having a area designated for raw meat preparation, marked by a sticker raw meat preparation was carried out on the same table that ready to eat food is prepared on, after thorough cleaning.

- remove laundry powder stored directly next to potato rumbler.
- remove office printer from main kitchen to office
- remove outer cardboard boxes from fridge when stored with ready to eat items.

**Guidance** The FSA (visit www.food.gov.uk for more information) has issued guidance on controlling E.coli 0157 through:

- •the complete separation of raw and ready-to-eat food
- the correct use of wash-hand basins and thorough handwashing
- •having dedicated equipment (including complex equipment) for raw and ready-to-eat foods
- thorough 2-stage cleaning and the correct use of sanitisers
- •and by controlling the risks posed by soily vegetables.

I suggest practices be reviewed in line with the FSA guidance and your own FSMS.

**Observation** I was pleased to see you were generally able to demonstrate effective controls to prevent cross-contamination.

**Observation** You have a dishwasher. You have no complex equipment. No complex

## Hand-washing

**Observation** I was pleased to see hand washing was well managed.

**Recommendation** Towels should be located in the wall dispenser.

### Personal Hygiene

**Observation** I was pleased to see that standards of personal hygiene were high.

### Temperature Control

**Observation** I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

### Unfit food

**Contravention** The following food was of a reduced quality and if sold may not be of the standard demanded by the consumer:

 Theos frozen halal chicken thigh use by 7.5.24. No additional labels had been applied to show when this had been frozen.

**Guidance** If you freeze high risk foods you must ensure that you freeze them before the USE BY date has passed. You must also have a good system to manage the food when you have defrosted it to ensure it is used before it becomes unsafe. In practice foods should be frozen at least a week before the USE BY date and when defrosted labelled with a date so that it is used within 2 days.

### **Poor Practices**

**Contravention** The following matters represented poor practice and if allowed to continue may cause food to become contaminated or lead to its deterioration:

 cardboard outers for cling film were dirty. I recommend plastic dispensers as they can be cleaned more easily.

## 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all excellent and you demonstrated full compliance with the law. There is evidence of effective pest control and procedures are in place to rectify any problems as they arise. There is good provision for waste disposal. (**Score 0**)

# Cleaning of Structure

**Observation** The kitchen had been well maintained and the standard of cleaning was exceptionally high.

# Cleaning of Equipment and Food Contact Surfaces

**Observation** You had colour-coded equipment on which to prepare food.

# Cleaning Chemicals / Materials / Equipment and Methods

**Observation** I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

## <u>Maintenance</u>

**Observation** You are maintaining the premises in good condition.

## Facilities and Structural provision

**Observation** I was pleased to see the premises had been well maintained and that adequate facilities had been provided.

### Pest Control

**Observation** You have a pest control contract in place and there is no evidence of pest activity on the premises.

## 3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. You have a good track record. There are some minor contraventions which require your attention. (Score 5)

## Type of Food Safety Management System Required

**Observation** Your Food safety management system was in place and generally working well apart from the matters outlined above.

**Observation** You were date labelling perishable foods appropriately and could demonstrate effective control over food spoilage organisms.

**Observation** You had colour-coded equipment and effective separation between raw and ready-to-eat food at all stages in your operation.

**Observation** You were monitoring (and recording) the temperatures of your fridges and freezers as well as the temperature of cooked/hot-held food and could demonstrate effective systems for controlling bacterial growth and survival.

## Food Hazard Identification and Control

**Contravention** The control methods you have put in place at the following critical control points are not sufficient:

 the matters as outlined previously under contamination risks and regarding the use by item. These matters must be addressed and amended as outlined in your own policy.

### Traceability

**Observation** Your records were such that food could easily be traced back to its supplier.

# Infection Control / Sickness / Exclusion Policy

**Observation** Policies were in place to prevent any infected food handler from contaminating food.

## **Training**

**Observation** I was pleased to see that food handlers had been trained to an appropriate level and evidence of their training was made available.

# <u>Allergens</u>

**Observation** You had identified the presence of allergens in your non-prepacked food and had brought this to the attention of your customers.
